

SPECIAL RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND PARENTAL CONSENT AGREEMENT FOR 2026 CARNEGIE ARTS CENTER SUMMER ART CAMP

Each child registered for Art Camp must have a parent or legal guardian fill out, sign, and return this Special Release and Waiver of Liability (“Release and Waiver”) before the first day of camp. For the purposes of this Release and Waiver, the term “Carnegie” shall mean the Carnegie Arts Center Inc. itself, its successors, instructors, assistants, current and former officers, employees, volunteers, servants, agents, attorneys, insurance carriers, and self-insurance pools.

I am the parent or legal guardian of _____, a minor child who is registered to participate in a Carnegie Arts Center’s Art Camp Program administered by the Carnegie Arts Center Inc. I have the authority to execute this Release and Waiver for myself, my child, and for my household.

_____ I understand that my child’s participation in the Carnegie Art Camp Program is fully voluntary, that the Carnegie does not warrant or represent the safety of me or my child by its hosting of the Art Camp Program or by using safety protocols, and that I am not relying on the Carnegie’s use of protocols to ensure safety of myself or my child.

_____ I accept sole responsibility for any injury to my child or myself or any member of my household (including, but not limited to, personal injury, illness, disability, and death), damage, loss, claim, liability, or expense, of any kind arising from infection or exposure to any contagious disease, including the coronavirus, that I or my child or any member of my household may experience or incur arising out of or related to with my child’s attendance at the Carnegie Art Camp (“Claims”).

_____ ON MY OWN BEHALF, AND ON BEHALF OF MY CHILD, I HEREBY FOREVER RELEASE, COVENANT NOT TO SUE, DISCHARGE, INDEMNIFY, AND HOLD HARMLESS THE CARNEGIE ARTS CENTER INC. (INCLUDING ITS SUCCESSORS, INSTRUCTORS, ASSISTANTS CURRENT AND FORMER OFFICERS, EMPLOYEES, VOLUNTEERS, SERVANTS, AGENTS, ATTORNEYS, INSURANCE CARRIERS, AND SELF-INSURANCE POOLS) FROM ANY CLAIMS, AND WAIVE ANY AND ALL RIGHTS TO ASSERT SUCH CLAIMS, INCLUDING ANY AND ALL LIABILITIES, ACTIONS, DAMAGES, COSTS, OR EXPENSES OF ANY KIND OF EVERY NATURE ARISING OUT OF OR RELATING THERETO.

_____ I agree that presentation of this Release and Waiver constitutes a complete and affirmative defense to any action asserting any Claims and that any such action shall be dismissed with prejudice upon presentation of this Release and Waiver.

I HAVE CAREFULLY READ THIS RELEASE AND WAIVER, FULLY UNDERSTAND ALL OF ITS TERMS, UNDERSTAND THAT MY CHILD AND I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
